## Barbaza MPC holds 53rd Annual Assembly

San Jose, Antique– Barbaza Multi-Purpose Cooperative held its 53rd Annual Assembly and the 7th Representative Assembly on March 11, 2018 with the theme "Sustained Productivity through Eco-Tourism and Economic Enterprise". The annual gathering of the representatives from the different districts of Panay Island was held at Binirayan Gymnasium, San Jose, Antique. A total of 384 members represented the nine (9) branches of BMPC from: Barbaza, Culasi, Sibalom, San Jose, Balasan, Barotac Viejo, Caticlan, Molo and Kalibo. Aside from the representatives, the assembly was also attended by CEO Felimon M. Espares, BOD Chairperson Corazon Tingson, BOD Vice-Chairperson Nicolas Valentin and the BOD Members: Ms. Feliza Necesario, Director on Delinquency, Mr. Johnny Luces, Director on Agriculture, Mr. Jessie Pido, Director on Finance and Investments, Mr. Ryan Alabado, Director on Youth and Development and Director Evelyn Remo, Director on Gender and Development, together with the members of the Committee on Election, Audit, Credit, Mediation and Conciliation, Ethics and the Committee on Education. To add color to the celebration, BMPC has also invited Guest Speakers: Hon. Elmer Untaran, the Municipal Mayor of San Jose de Buenavista, Hon. Rhodora Cadiao, Governor of Antique, Mrs. Feliza E. Labrador, Manager of Antique Federation of Cooperatives (AFCCUI) and Hon. Gadwin E. Handumon, National Anti-Poverty Commission Commissioner, Coop Sector Representative.

During the assembly, the Cooperative's comprehensive report on its operations for the year 2017 was presented. Included in the report are the Coop's activities and financial performance of the preceding year, the reports of the BODs' in their respective portfolio and of the committees. The Management Report was done by the COO, Mr. Leonil Alabado. The External Auditor on the other hand discussed the the Statement of Comprehensive Income, Statement of Changes in Member's Equity,

Statement on Financial Position and Statement of Cash Flows. The assembly approved the proposal presented by the CEO Mr. Felimon Espares regarding implementation of the new minimum share capital of the members which is now Php2,500.00 to be considered as bonafide members and to avail the mortuary benefit. Other major approved resolutions were: Buying/transfer of share capital of members of the cooperative as treasury shares will be based on the book value of 100% at any timeline having only a processing fee of 5% of the amount but not to exceed Php10,000.00 and the purchase of 2 lots in Janiway with a total of 357 sq. m for the branch expansion.

The election of the set of Officers of the Board and Elective Committees ensued after the assembly. Elected were: BOD Chairperson: Ms. Corazon Tingson, Vice Chairperson: Ms. Feliza Necesario, Members: Mr. Ryan Alabado, Mr. Johnny Luces, Mr. Teodoro Ballarta, Mr. Alexander Amantillo Jr. and Mr. Jessie Pido. Elected for the Election Committee was Mr. Jose Noel Alcubilla and Rev. Rommel Marcelino, Joemar Semillano and Jacobina Alabado for Audit Committee.

A raffle draw capped the assembly, 1st prize, a 40" Flat Screen LED TV went to Ms. Harly Mabaquiao from Barbaza Main Branch, 2nd prize, a Lenovo Laptop was bagged by Mr. Benjamin Alojado, Jr. from Culasi Branch and 3rd Prize, a Washing Machine was won by Ms. Aurora Flores from Barbaza Main Branch. Twenty kitchen wares and appliances worth of Php2,000.00 each were drawn and given to lucky winners.


### Did you know?


# 2018 MID YEAR MANAGEMENT REPORT


For the past six months Barbaza Multi-Purpose Cooperative has been successful on its operation, delivering its target in terms of key areas of operation like membership, savings generation, loan released and surplus. With this indicators there's no doubt Barbaza MPC will continue to soar high. Barbaza Multi-Purpose Cooperative became one of the few cooperatives that still enjoy its status as most awarded and outstanding cooperative not only on the region but throughout the nation and the organization is still looking forward for better organization to its thousands members across the region.




Membership among branches reached a total of 75, 404 ending June 2018 or an increased of 9.56% from 2017 total membership. The increase on numbers only shows that Barbaza Multi-Purpose Cooperative is one of the trusted cooperatives in the region. With the aim of extending the organization's excellent products and services, Barbaza Multi-Purpose Cooperative continuously explore areas where the organization believes prospective members can patronize and benefit. One area expected to open this coming September is the Janiway Branch in the province of Iloilo which operation will also cover adjacent municipalities. With this, Barbaza Multi-Purpose Cooperative is expecting higher percentage of increased membership comes year end.



The aggregate amount of Savings and Time Deposit as of June 2018 is Php 620,415,278 an increased of 13.58% while share capital has the aggregate amount of Php 498,240,086 an increased of 18.66% compared to 2017 data. This year, the management developed a depositing raffle promo to help increase the savings and share capital generation. One raffle ticket will be given every Php200.00 additional share capital and also one raffle ticket for every Php5,000.00 additional savings or time deposit. Prizes include: 1st prize: Motorcycle; 2nd prize: Videoke Machine; and 3rd Prize: Solar Lighting Package. Promo ends in December 31, 2018 and raffle draw will be on March 2019. With this promo the management is hopeful that the organization can surpass the target set for the year 2018.



Credit Division being the main business of the cooperative has released a total amount of Php 1.1 Billion as of June 30, 2018. Barotac Viejo Branch released the highest amount with 18.96% of the total amount followed by branches in Barbaza and Balasan with 15.13% and 15.07% respectively. Barbaza Multi-Purpose Cooperative offers loan windows from productive type of loan to providential loan depending on the needs of the member borrowers. With the 2018 target of Php 2.3Billion, Barbaza Multi-Purpose Cooperative will still have more than a billion to release on the remaining six months. The organization believes that the cooperative is still the prime option in providing the financial needs of its members.



Barbaza Multi-Purpose Cooperative has the positive outlook that the net surplus earned by each service for the 2 quarters will continue to increase on the remaining months. The total net surplus as of June 2018 recorded to Php52, 671, 796.89. Credit division delivers the highest surplus which is 90.68% of the total given that it is the main source of surplus of the organization followed by Cable TV and Internet and Gas Station with 7.21% and 1.18% respectively. Other services continue to gain and will continue to deliver surplus to the organization. The unending support of the members by patronizing its product and services is a big help why the organization enjoys the increasing surplus throughout the years. With higher surplus, the members can expect higher amount of surplus to be distributed as dividend comes March 2019.

## SOCIAL SERVICES

# EDITORIAL: STEP UP FOR GENDER AND DEVELOPMENT

**G**ender and Development (GAD) refers to the development perspective and process that is participatory and empowering, equitable, sustainable, free from violence, respectful of human rights, and supportive of self-determination and actualization of human potentials. We recognize that women comprise more than half of the human population. Thus, they have much to contribute to society. If more than half of the population is prevented from contributing to society, most likely, that society will be stunted and impoverished. Gender and Development or GAD is not only about women, but as much as possible, we are trying to picture a scenario that both women and men work together. The objective of GAD in Gender Equality (GE) is to ensure that where women and men have the same value, equal rights, commitment, visibility, empowerment and participation in all spheres of public and private life. This requires the acceptance and appreciation of the complementarity of women and men and their diverse roles in the society.


In our society today, this seeks to achieve gender equality as a fundamental value that should be reflected in developmental choices and contends that women are active agents in development, not just passive recipients of development, acknowledging their contribution inside and outside the household.

This is the highlight in the Memorandum Circular 2013-22 issued by the Cooperative Development Authority (CDA) entitled the "Guidelines on Mainstreaming Gender and Development (GAD) in Cooperatives." This aims to disseminate to the cooperative sector the GAD mandate of the government. This is to ensure the promotion of Gender Equality and institutionalization of GAD policies, programs and other activities of the cooperative. This CDA MC 2013-22 stands and reinforces in the existing legal basis for GAD in the Philippines. The 1987 Constitution says in Article II Section 14: "The state recognizes the role of women in nation building and shall ensure the fundamental equality before the law of women and men." RA 9710 or the Magna Carta of Women (enacted July 2008) guarantees women their: 1) Human Rights, 2) Protection from violence, 3) Protection during Disaster, 4) Participation and representation in government policy-making processes, 5) Equal treatment before the law, 6) Equal access to education, 7) In sports, 8) In Military, 9) Non-derogatory in media and film, 10) Right to health, 11) Special leave benefits, and 12) Equal rights in family and marriage.

Also, Executive Order (EO) 273 or the Philippine Plan for Gender-Responsive Development (PPGD) 1995-2025 outlines the policies, strategies, programs and projects that the government must adopt to enable women to participate in and benefit from national development.

In faithful compliance and support, Barbaza MPC is defining its GAD Program which acknowledges the "equal and inalienable rights" of every individual, and the "recognition and protection of their fundamental human rights and freedoms. Consequently, women and men must participate equitably in the development for any adequate measure of sustainability to be realized. We make certain that gender equality and equity must be central to all coop development initiatives. To achieve substantive equality, it is important that men and women are not discriminated against because of social norms and expectations. The core role of the BMPC GAD Program is to endow every individual with the required conditions for actualizing human functioning, in other words, to provide them with necessary capacities and opportunities, and must arrive at the basis for a good quality of life and well being for all, and the most effective and sustainable development outcomes. It is our desire that to incorporate a gender perspective in all development planning as the strategy for promoting gender equity and 'fairness' so that development planning itself becomes fundamentally gendered and to identify and establish a framework with the mandate to initiate, coordinate, implement, monitor and evaluate gender responsive development plans.

It is worth emphasizing that gender equality strives for a balance between both sexes. This program is committed to ensuring that the concerns of both sexes are examined and addressed in the areas which have been deemed most important.

## COOP BASICS Glossary of Useful Terms

- 1. Common Shares Capital** shall be issued only to regular members. Its holders shall be entitled to vote and be voted under the principle of one-man, one vote principle, and shall receive interest, the rate which should not exceeded the normal rate on investment.
- 2. Preferred Share Capital** may be issued to regular and associate members. However, associate Members shall not be eligible to vote nor be voted on account of such shareholdings but shall be entitled to, among others the following: **a.** Preference in the payment of interest as provided for in the Bylaws of the cooperative; and **b.** In case of liquidation, priority in the distribution on Preferred Share Capital shall be prescribed in the By-laws of the cooperative.

**BMPCIANs** provides an opportunity to celebrate all the successes of the Cooperative and provide news about our Coop. It is designed to inform members and also non-members about the achievements and the relevant opportunities at Barbaza Multi-Purpose Cooperative. The publication keeps people well-informed and up to date with the latest events. It is another important element in establishing strong member-cooperative relations.
